Patient Support

Provided funding for research in finding a cure for Pachyonychia Congenita. Maintained a web site to provide information about and assist research efforts. Provided support meetings to individuals affected by Pachyonychia Congenita. Provided individual support as needed for patients via emails, telephone calls, or through the help of PC patient advocates or members of the PC Scientific and Medical Advisory Board. More support is outlined next in the resources and benefits through membership in the IPCRR.

IPCRR

Maintained the International Pachyonychia Congenita Research Registry (IPCRR). Since 2004, and with IRB approval, the IPCRR has provided over 1,900 patients free genetic testing, physician consultations, patient meetings, chat groups, special web meetings, and monthly patient newsletters. Through the IPCRR, patients also have opportunities to participate in clinical trials and studies.

Sponsored the International Pachyonychia Congenita Consortium (IPCC). Since 2004, the IPCC has held annual scientific meetings, awarded research grants, coordinated research with both academic and private institutions, conducted monthly web meetings with the IPCC genetics team, established and met annual research goals, and distributed quarterly newsletters to over 200 physicians and scientists. Working with leaders in the IPCC, clinical trials have been completed and numerous clinical and research studies have been conducted. It is estimated that nearly 100 articles have been published in leading scientific journals by the Organization or its IPCC members, a number of which cited IPCRR data and research and clinical studies done through IPCC.

Pachyonychia Congenita (PC) is an ultra-rare skin disorder which causes painful blisters and calluses on feet as well as thickened nails, cysts, and other painful symptoms. The Organization's primary goals have been (1) to interest leading scientists and physicians who specialize in keratin disorders in research for the ultra-rare disorder, PC, and to establish collaboration among researchers; (2) to establish and maintain an international PC Patient Registry (IPCRR) as a resource for scientific research; and (3) to provide education and support for physicians, scientists, and PC patients and their families worldwide. By their very nature, these types of activities have the potential to attract support from governmental units and public charities on a continuous basis. At no time has the Organization conducted activities which serve the personal or private interests of its founders or related parties.

The Organization maintains a continuous and bona fide program for solicitation of funds. Brochures requesting donations are widely distributed at scientific, patient support, and public events. These brochures are also distributed through direct mailings to personal and professional contacts. Grant applications have been made to foundations and others.

In February 2004, the Organization organized the first international PC conference in which 23 of the leading keratin specialists attended, including Mario Capecchi (Winner of the 2007 Nobel Prize for Medicine). At the meeting, the group formed the International PC Consortium (IPCC) to encourage collaboration for PC research. There are now several hundred experts who are active members of the IPCC and each has agreed to collaborate and share reagents and expertise to assist other IPCC members in regard to PC research and patient care. The majority of these participants represent non-governmental organizations that serve members of a charitable class in their home countries. A list of participants can be provided if needed. Beginning with the 2004 Symposium, the Organization has sponsored an annual scientific meeting each year. The Organization also provides expertise directly for the benefit of the general public by responding to dozens of telephone, mail, and internet inquiries each week at no charge from public health officials, practitioners, and members of the general public. In many cases, members of the medical and scientific advisory board will provide responses when specific scientific or medical opinions are needed. The IPCC has organized a steering committee to direct efforts of the IPCC and three working teams, including (1) a research team conducting basic and translational research, (2) a diagnostics and genetics team, and (3) a physicians network. Each of these teams actively provide public service to those with PC and many other related skin disorders.
